General Terms and Conditions :

1. The tender is in two-part system (Technical Bid and Price Bid). The tender with separately marked envelopes Technical Bid and Price Bid be put in a single large envelope, sealed and may be submitted to Deputy Registrar (Stores & Purchase), Indian Institute of Technology, Kharagpur-721302 within the stipulated period as mentioned hereunder.
 - (i) Last date of submission of Technical Bid and Price Bid: **23.02.2012 upto 2.30 P.M.**
 - (ii) Opening of Technical Bid : **23.02.2012 at 3.30 P.M.**
2. Validity of the Quotation : 90 days from the date of opening of Price Bid.
3. Price : Should be in Indian Rupees.
4. Tax : If applicable, to be clearly mentioned. The Institute will not provide C or D Form. Excise Duty Exemption/Custom Duty Exemption Certificate and Inter-state transit Way Bill (Form-50) will be issued only in favour of the bidder and address as mentioned in the Purchase Order.
5. Freight & Insurance : No freight and insurance charges will be provided and the materials are to be delivered at IIT Kharagpur at the cost and risk of the vendor.
6. Institute reserves the right to change the quantity to be tendered and vendor must have the ability to supply any additional quantity within the validity of the quotation period.
7. No advance is payable against supply of stores.
8. The financial bids of only those vendors shall be opened whose technical bids are found suitable. No conditional bids will be accepted. It will be obligatory on the part of suppliers/vendors to submit complete documentation, authorizations, exemptions, etc. wherever applicable.
9. In case of dispute, the matter shall be settled mutually, failing which the decision of the director shall be final and binding.
10. This is an Open-Bid system. Bidders/vendors are permitted to attend the Techno-Commercial Bid/Price Bid Meeting subject to production/submission of letter of authority. No separate letter will be issued in this respect.

11. Payment terms : 90% payment shall be released after receipt of stores in good order and condition and duly certified by the Head of the concerned Deptts./Centres. Balance 10%, so retained shall be refunded after one month of the end of supply on submission of Bank Guarantee towards Performance Guarantee for the equivalent value of Security Deposit valid for the five years Warranty Period plus sixty days drawn on any Commercial Bank.
12. Liquidated Damages : The stores should be delivered/dispatched to destination and ready for operation not later than the delivery date specified. If the supplier fails to deliver the stores or perform the service by the specified date, liquidated damages at 1% per month or part thereof in respect of the value of stores will be deducted from the contract price subject to a maximum of 5%. Alternately, the order will be cancelled and the undelivered stores purchased from elsewhere at the risk and expenses of supplier.

Note : In case due date happens to be holiday, the tender will be accepted and opened on the next day. The timings will however remain unchanged.
